# Agenda Item 4: Evaluation of the Head Football Coach and Football Program at SUBR (Executive Session)

On motion of Atty. Cunningham, seconded by Mr. Fontenot, the Board convened into an executive session to discuss personnel matters regarding the football program at SUBR.

Motion carried unanimously. Roll call vote: 15 yeas, 0 mays.

Mr. Scott Dyer, reporter for the Morning Advocate newspaper registered his objections to the executive session.

In response to Mr. Sensley's inquiry, Coach Gerald Kimble indicated that he had no objection to the executive session.

On motion of Dr. Stone, seconded by Rev. Gant, the Board reconvened into open session.

Motion carried unanimously. Roll call vote: 15 yeas, 0 mays

Mr. Sensley announced that while in executive session, the Board discussed the evaluation of the head football coach and the football program. The Athletic Director and Head Football coach made presentations during the session and no actions were taken.

# Agenda Item 5: Consideration and recommendations on the future of the football program and all facets thereof, including personnel, SUBR

Pursuant to recommendations from the SUBR Chancellor and the Athletic Director, President Spikes recommended to the Board that the contracts of Head Football Coach Gerald Kimble and the assistant coaches not be renewed, effective at the end of the contract period, December 31, 1991.

On motion of Mr. Higginbotham, seconded by Mr. Moore, the Board accepted the recommendation regarding football coaching personnel at SUBR.

The motion carried. Roll call vote: 14 yeas, 1 may (Nay: Rev. Joe Gant)

Dr. Stone requested that the record reflect that he cast a yea vote because he respected the administration's right to make decisions, even though, in this instance, he disagreed with it.

President Spikes advised the Board that Chancellor Yates had discussed with the Athletic Director and with her various matters regarding the athletic program.

The Board received an overview from Dr. Yates on efforts to provide direction for the overall athletic program, specifically, the football program.

Current initiatives include discussion with various University personnel regarding the production of a quality athletic program, including facility and budgetary needs.

Chancellor Yates read excerpts from the job description which was developed for the head football coach's position. This description, he noted, can be adapted for head coaches of the other sports at the University.

Dr. Yates also reported that he will direct the Athletic Director to have each head coach develop a five-year plan by May 31, 1992. This plan will include objectives, goals and the philosophy of each sport. An annual report on accomplishments will be submitted to the Athletic Director no later than May 31 each year.

Dr. Stone voiced his support of the Chancellor's efforts to enhance the athletic program. He also indicated a need to have the following information to assist him in making decisions when athletic matters are brought to the Board for action in the future:

- Responsibilities of the Athletic Director.
- 2. The anticipated relationship between the Athletic Director and the head football coach.
- 3. The Athletic Director's responsibilities in reference to the Bayou Classic.
- 4. A full job description for the Athletic Director which describes his responsibilities as they relate to stadium management, parking, etc.
- Rationale for a five-year plan for the athletic programs.
   Improvements expected from each head coach during this period.

6. Incentives for the performance of the head football coach, i.e., annual merit increases rather than a fixed amount over the contractual period.

Discussion continued regarding a deadline for the Administration to submit to the Board its recommendation for the employment of a head football coach, as well as the number of names to be submitted.

On motion of Rev. Bilberry, seconded by Mr. Owens, the Board directed the administration to submit one recommendation for filling the head football coach position, including the employment contract, at its January, 1992 meeting.
