D. Facilities and Property

(1.) LEASE OF J.K. HAYNES BUILDING, SULC

RESOLVED by the Board of Supervisors for the Southern University and Agricultural and Mechanical College System that the agreement between the Southern University Board of Supervisors and the J.K. Haynes Estate for leasing approximately 3,301 square feet of usable space located at the 7980 Scenic Highway in Baton Rouge, LA., effective July 1, 2007 through June 30, 2008, with an option of renewing for an additional one-year period be and it is hereby ratified.

The facility is to be used by the Southern University Law Center for the Clinical Education Program as an office, with twenty-five parking spaces provided.

The annual cost of the lease is \$36,000 payable in 12 equal monthly installments of \$3,000, commencing on the 1st day of July 2007.

(1.) STUDENT HEALTH AND ACCIDENT INSURANCE RENEWAL

(2.) PROPOSED PAY PLANS FOR FACULTY AND/OR UNCLASSIFIED PERSONNEL, 2007-2008

RESOLVED by the Board of Supervisors for the Southern University and Agricultural and Mechanical College System that the following proposed pay plans for the Campuses and System personnel be and they are hereby approved.

SUBR

- Fifty percent of the dollar amount, per Board of Regents Faculty Pay Plan Guidelines, for an across-the-board pay increase; and the remaining half at 2.2 percent for all faculty pay plan recipients, based on current salary - \$1500 award added to each Unclassified Employee's annual salary

SUNO

- One-half of the appropriated funds will be divided equally among faculty, per Board of Regents' mandate, plus a supplement provided by the University to ensure that faculty receive the same amount of increase (\$1500.00) as allocated by the State for unclassified personnel.
- Equity pay for Faculty and Staff to bring affected employees within at least 90% of the salary of their SREB counterparts.
- Salary increase for adjunct faculty from \$1,700 per Semester to \$2,000 per Semester.
- Merit increase for faculty and staff not to exceed 2% of their salary, based on written performance evaluation/review per University and System guidelines.
- Relocation stipend, not to exceed \$2,000, for new faculty and administrative personnel who are employed by SUNO from outside the state of Louisiana.

SULC

- Fifty percent of the State funds allocated for faculty pay increases will be used to provide the thirty-five eligible faculty members and librarians equal salary increases, plus related benefits.
- A salary increase of \$1500 provided by the State and an additional increase to address equity issues for all unclassified employees

SUAREC

- 5% pay increase for personnel classified as faculty

SUSLA

- \$1,017 pay increase per faculty member and the remainder distributed as a 2.5% across-the-board increase
- Salary adjustment of \$1500 for unclassified and classified employees.

BOARD AND SYSTEM

- Salary adjustment for all unclassified employees of \$1500 as provided by the State

(3.) MASTER PLAN FUNDING REQUEST, SUNO

RESOLVED by the Board of Supervisors for the Southern University and Agricultural and Mechanical College System that Southern University at New Orleans be and it is hereby authorized to accept the Master Plan and Development Proposal submitted by St. Martin Brown and Associates, L.L.P. in the amount of \$225,000.

(4.) FUNDS FOR DESIGN WORK FOR SUNO RESIDENTIAL HOUSING

These funds will be included with the \$44 million to increase the number of beds and ultimately increase SUNO's revenue stream.
