AGENDA ITEM 5: UPDATE AND DETAILS OF THE PROPOSED IMPLEMENTATION STRATEGY OF THE 2009-2010 FISCAL YEAR BUDGET REDUCTION, SU SYSTEM ENTITIES

The Southern University Administration presented the Board and System Administration and the Campuses' preliminary budgets depicting mandated 2009-2010 reductions and amendments, per House Bill No. 1, as of May 7, 2009:

In addition, pending amendments to House Bill 1 are expected to provide \$200,000 for the SU Lab School and \$1 million for the SU Ag Center. House Bill 1 is expected to be debated on the House Floor on May 14.

The President advised that meetings were being held daily between higher education officials and legislators in an attempt to free up additional funds to minimize the proposed budget reductions.

The President also reported the Governor's efforts via Senate Bills 1 and 2 to seek to undedicate some funds in order to lessen the amount of future cuts to higher education and health and hospitals.

Each of the Chancellors and the President presented strategies that will be implemented by their respective units as needed to respond to the expected loss of funds from State mandated budget cuts. The Chancellors also advised the Committee of meetings which have been held with various groups on their respective campuses regarding the impending budget cuts.

Some of the strategies that are being considered for implementation by the System and the Campuses in response to the budget cuts are –

- -Personnel cuts, including temporary and adjunct faculty
- -Elimination of vacant positions
- -Employee furloughs
- -Reductions in library, travel, supplies, and operating services
- -Increase in Student Tuition

The Administration was requested to keep the Board apprised of the status of the mandated cuts on the University's budgets.
