AGENDA ITEM 5: UPDATED PREVIEW OF UPCOMING LEGISLATIVE SESSION

The Committee received a draft copy of Southern University and A&M College System at a glance. The document which will be distributed during the Legislative Session and to the public at large provides a synopsis about the University's System Campuses, history, distinguished alumni, and general information.

A Legislative update was provided by Mr. Jason Hughes. Copies of the following documents were distributed to the Committee.

- LEGISCON The Legislative Bill
 Tracking Report which showed pre-filed legislation affecting appropriations,
 Boards and Commissions, Capital Outlay, Guns on Campus, Higher Education,
 Purchasing and Procurement, Employee Retirement, and Tuition.
- Digest of HB996 to create the Louisiana University System Board of Trustees to supervise and manage the State's public colleges and universities that issue baccalaureate degrees; abolishes the LSU Board, SU Board, University of Louisiana Board; and provides for the powers of the new Louisiana University System Board and the Community and Technical Colleges Board
- 2010 Regular Legislative Session Priorities which include the SU System's position on various recommendations from the post secondary education review commission
- Three Budget Reform Initiatives to improve budget flexibility
- Federal Earmarks for the SU System
- Following the Committee's review of pre-filed legislation and other general information, the members discussed means by which the Board could interact with Legislators to garner support for the University during the 2010 Regular Session. In addition to Board Members' personal contracts, a Board - hosted social activity was considered as a forum for governing Legislators' support for the University.

AGENDA ITEM 5: AFTER -ACTION ASSESSMENT OF BAYOU CLASSIC 2009

Dr. Ernie Hughes, Director of the Southern University System Foundation, reported that the joint Bayou Classic Southern Committee which is composed of Southern University and Grambling State University representatives is currently developing recommendations for improving the Bayou Classic, beginning in 2010 and securing corporate sponsorships. The report will be submitted to the respective Foundation Boards of the two universities; and, to the Southern University Board of Supervisors via its Bayou Classic Committee in April. A 4-way Cooperative Endeavor Agreement by and between Southern University and Grambling State University and their Foundation Boards will also be presented.

AGENDA ITEM 6: TIMETABLE FOR PROVIDING RESULTS OF 2009 BAYOU CLASSIC AUDIT

The Committee was advised that Southern University and Grambling Foundations have agreed to conduct separate audits. The completed audit report for Southern University is expected during the coming weeks and will reflect a breakdown of Bayou Classic 2009 revenues and expenses. Future cost savings recommendations will also be submitted.

AGENDA ITEM 7: EXISTING BAYOU CLASSIC MARKETING SERVICE AGREEMENT

The current Marketing Service Agreement between the Bickerstaff Group, the Southern University System Foundation and the Grambling Black and Gold Foundation will expire on December 31, 2010. The following options are being considered for marketing the Bayou Classic, beginning in 2011:

- Option 1 Southern University and Grambling State University jointly hire a Bayou Classic Coordinator to be responsible for (1.) soliciting and securing corporate sponsors; (2.) Coordinating all affiliated events in conjunction with each University's Coordinator; and (3.) providing monthly reports on Bayou Classic goals and timelines. Option 1 also provides for the hiring of a Game Day Manager.
- Option 2 A Request for Proposals (RFP) would be advertised for hiring of a new marketing company at a reduced fee and with service options.
- Option 3 Request for Proposals would be advertised for hiring a Game Day Manager and a Marketing Service Representative
