LOUISIANA SUPREME COURT JUSTICES CONDUCT ORAL ARGUMENTS AT SOUTHERN UNIVERSITY LAW CENTER

The Louisiana Supreme Court held oral arguments at Southern University Law Center (SULC) on Monday, March 17, 2025. Law Center students, faculty, and staff were invited to attend. Each of Louisiana's four law school deans traditionally invites the Supreme Court to conduct oral arguments on their campuses.

The Louisiana Supreme Court's docket included four cases. The 19th Judicial District Court retired Judge Richard Anderson sat as Justice ad hoc for Justice Griffin who recused for one case. Three cases were heard at LSU on Tuesday, March 18, 2025. After oral arguments concluded, the Justices had discussions with students and faculty about the justice system and the importance of professionalism in legal practice. Notably, Chief Justice John L. Weimer and Justices Jefferson Hughes, William J. Crain, Jay B. McCallum, and Piper D. Griffin are graduates of LSU Paul M. Hebert Law Center; Justice John Michael Guidry is a Southern University Law Center graduate and Justice Cade R. Cole is a Tulane University Law School graduate.

This event marked the first time that newly elected Louisiana Supreme Court Justice Guidry and Justice Cole participated in law school visits as Supreme Court Justices. In January 2025, Justice John Michael Guidry was elected as an Associate Justice of the Louisiana Supreme Court for the Second District, after serving 27 years on the First Circuit Court of Appeal, including two years as chief judge.



In March, Justice Cade R. Cole, who served as Louisiana's first state and local tax judge, was elected Associate Justice of the Louisiana Supreme Court for the Third District.

Following the oral arguments, the Law Center hosted a reception to honor Justice John Michael Guidry and celebrate his historic appointment.

Vice Chancellor Ramsey opened the session by emphasizing the importance of making legal scholarship more accessible and impactful. Professor Stephenson followed with a detailed discussion on practical steps faculty could take to navigate alternative publishing options.

The workshop equipped SULC faculty with fresh strategies to enhance their research visibility and influence. It was a productive reinforcing the Law Center's commitment to academic excellence and innovation.



SULC JOURNAL OF INTERNATIONAL LAW, BUSINESS, AND POLICY SYMPOSIUM HIGHLIGHT GLOBAL INTERSECTIONS

Southern University Law Center's Journal of International Law, Business, and Policy hosted its 2nd Annual Symposium on Global Intersections: Navigating the Nexus of International Law, Business, and Policy.

This virtual symposium provided a comprehensive exploration of key global issues, including International Criminal Law, National Security, and Global Health Threats. A featured presentation by LexisNexis highlighted how to use legal research tools and methodologies.

During the symposium, speakers discussed the impact of federal AI regulations on data privacy, global labor standards, and cross-border labor relations. Additionally, participants learned about the Temple University Japan's study abroad program and other critical topics shaping international law and policy.

SULC'S MOCK TRIAL TEAM SHINE AT NATIONAL BLSA COMPETITION

The Southern University Law Center (SULC) was proudly represented at the National Black Law Students Association (NBLSA) Mock Trial Competition by law students William Gaspard Jr., Jada Haynes, Aaron Manzy, and Alexis Blanton. Competing against top teams from across the nation, the team showcased exceptional advocacy skills, earning an impressive team score of 80 out of 100.

Haynes and Gaspard secured a ballot victory in the second preliminary round, while Manzy and Blanton achieved the team's highest individual scores. Earlier in the season, the team made history by winning the first Mock Trial championship for an SULC team since 2021 at the regional tournament

Berry Institute for Civil Rights and Justice, who encouraged participants to stay informed and actively contribute to shaping the future of justice.
