The Technology and Entrepreneurship Clinic is pleased to announce the resource partnership with HP LIFE, a free program of the HP Foundation.


The objective of this partnership is to support education, social entrepreneurship, business development, and innovation.




BAR EXAM UPDATE

Chancellor Pierre, alongside three Louisiana law school deans, expressed their concerns to the Louisiana Supreme Court regarding the swift decision to cancel the July Louisiana Bar Exam, merely days before it was set to be administered. Soon after canceling the Bar Examination, an emergency admission rule was passed, waiving the requirement of bar passage for the Classes of 2019 and 2020.



Baker, a recent graduate, was appointed to the American Bar Association's Death Penalty Due Process Review Project.




